A RESOLUTION GRANTING PERMISSION TO MR. JORG GLASBRENNER, A GERMAN NATIONAL, TO CONDUCT AN ASSESSMENT AND IMPLEMENT A CORAL REHABILITATION PROGRAM IN THE REGISTERED MARINE SANCTUARY LOCATED IN BARANGAY ESPERANZA, INOPACAN, LEYTE

WHEREAS, the Barangay Council of Esperanza recognizes the importance of marine sanctuaries in preserving marine biodiversity, protecting coral reefs, and sustaining the livelihoods of local fisherfolk;

WHEREAS, Mr. Jorg Glasbrenner, a German national who owns a house and lot in Barangay Esperanza, Inopacan, Leyte, has expressed his willingness and commitment to conduct an assessment and implement a coral rehabilitation program in the registered marine sanctuary located in Barangay Esperanza;

WHEREAS, the proposed program aligns with the barangay's environmental conservation initiatives and is expected to enhance the marine sanctuary's ecological health, benefiting both the local environment and community;

WHEREAS, Mr. Glasbrenner has the technical expertise and resources to undertake the project and has assured compliance with all applicable local, national, and international laws and standards;

WHEREAS, the Barangay Council of Esperanza deems it in the best interest of the barangay to grant permission for this endeavor, subject to coordination and proper monitoring by the concerned authorities;

NOW, THEREFORE, on motion of Hon. Alan L. Ramos and duly seconded by Hon. Alma R. Andr5ade, it is hereby resolved by the Barangay Council of Esperanza, Inopacan, Leyte, in session assembled:

1. **To grant permission** to Mr. Jorg Glasbrenner to conduct an assessment and implement a coral rehabilitation program in the registered marine sanctuary located in Barangay Esperanza, Inopacan, Leyte.
2. **To require** Mr. Glasbrenner to coordinate with the Barangay Council, the Municipal Environment and Natural Resources Office (MENRO), and other relevant agencies to ensure compliance with environmental guidelines and proper documentation of the project.
3. **To monitor** the progress of the program through a designated barangay representative and submit regular updates to the Barangay Council.
4. **To endorse** this resolution to the Municipal Council of Inopacan for their information and further support.

RESOLVED FURTHER, that this resolution shall take effect immediately upon approval.


